

## ANNEX B

### NOTICE UNDER ARTICLE 8(4) OF THE GAS (NORTHERN IRELAND) ORDER 1996

Pursuant to Article 8(4) of The Gas (Northern Ireland) Order 1996 (“the Order”) the Northern Ireland Authority for Utility Regulation (“the Authority”), hereby gives notice as follows:

- 1) The Authority proposes, in accordance with Article 8(2)(a) of the Order, to extend the licence to convey gas held by Phoenix Energy Group Ltd (the “Licensee”) by increasing the Licensed Area to include the following:
  - (a) The United Renewables Area surrounding the United Renewables AD plant, lands 150 metres southwest of 5 Hannahstown Road, Slievenacloy, Lisburn, County Antrim BT28 3TB;
  - (b) The Bowtown Area surrounding the RGWP Ltd AD plant, 91 Bowtown Road, Newtownards, County Down, BT23 8SL;
  - (c) The Rea Hill Area surrounding the Rea Hill Farm Ltd AD plant, lands 166 metres north of 10 Rea Hill Road, Newtownabbey County Antrim, BT36 5SF;

where:

- (d) The United Renewables Area is the geographical area falling within the boundary delineated by the blue-green line, as shown on the map set out in Appendix 1;
  - (e) The Bowtown Area is the geographical area falling within the boundary, delineated by the blue-green line, as shown on the map set out in Appendix 2; and
  - (f) The Rea Hill Area is the is the geographical area falling within the boundary delineated by the blue-green line, as shown on the map set out in Appendix 3.
- 2) The Authority’s reasons for its proposal to grant the requested licence extension on a non-exclusive basis are set out in chapter 2 of the consultation document published alongside this notice.
  - 3) The drafting proposal for extending the Licensee’s gas conveyance licence is set out in Annex A to the consultation document published alongside this notice.

- 4) The purpose of this notice is to bring the proposed licence extension to the attention of persons likely to be affected by them, and to invite representations or objections in connection thereto. In line with Article 8(4) of the Order, any representations or objections with respect to the proposed modifications may be made on or before 12 noon on 9 January 2025 to:



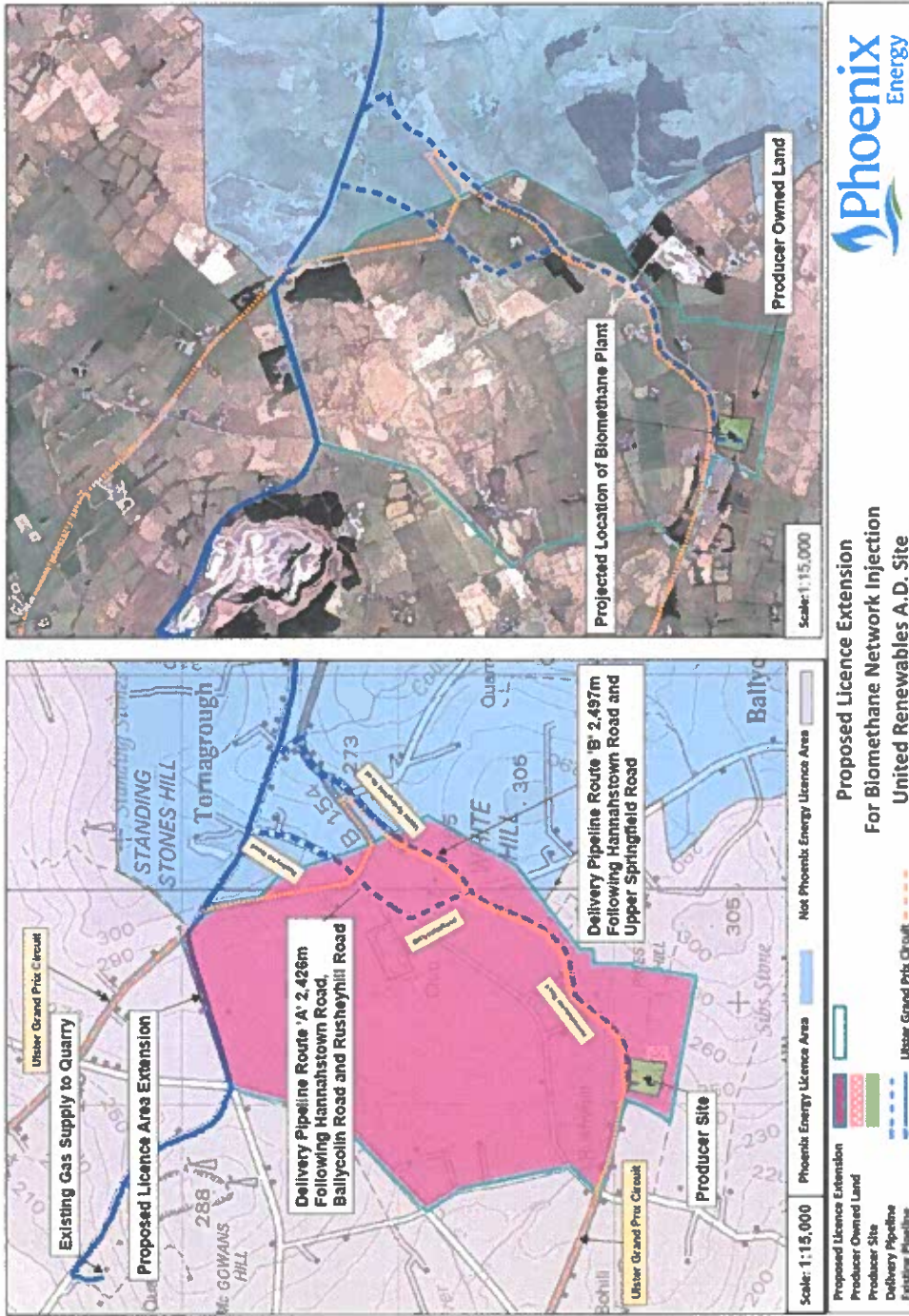

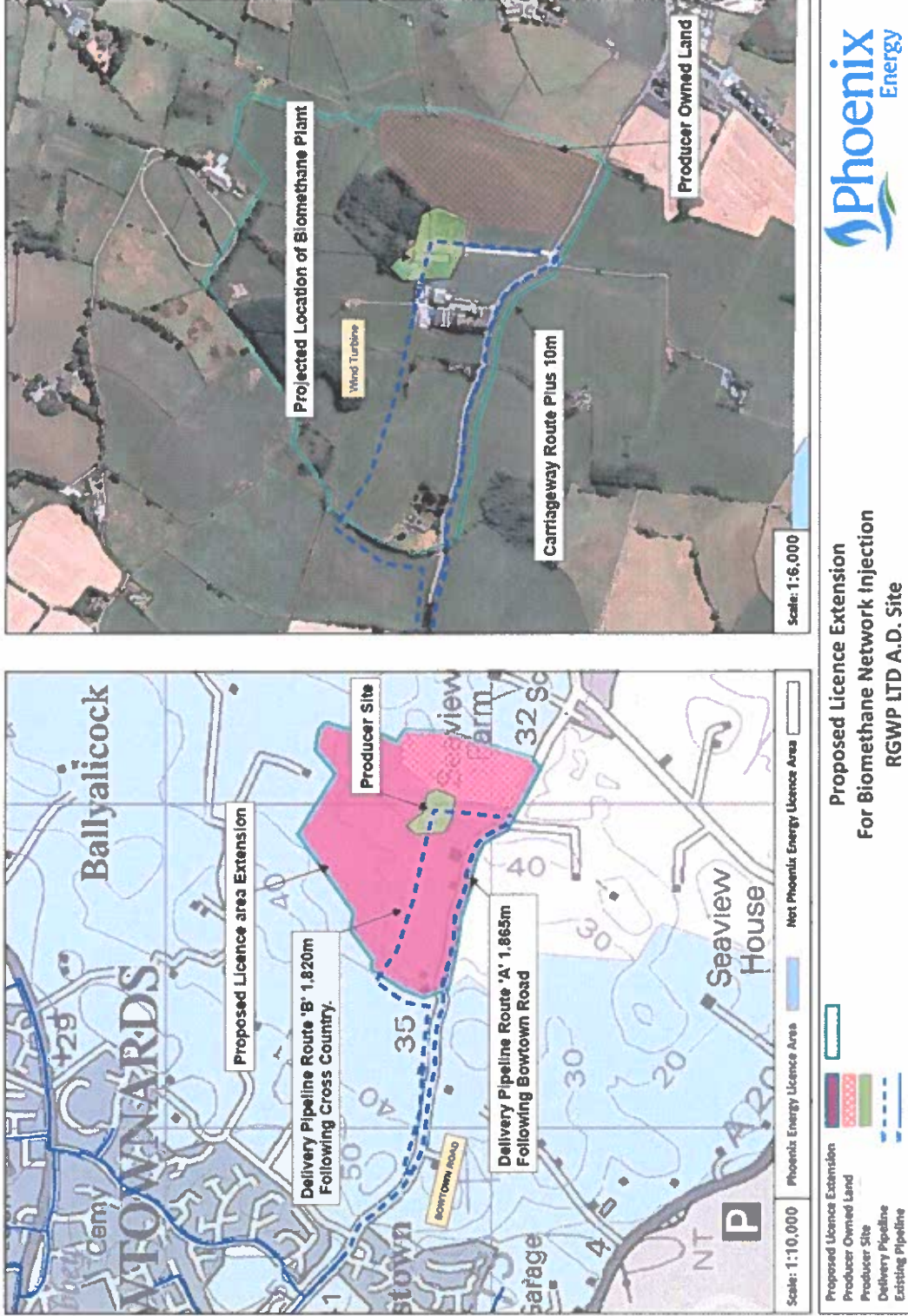
