THE NORTHERN IRELAND AUTHORITY FOR UTILITY REGULATION NOTICE UNDER ARTICLE 14(2) OF THE GAS (NORTHERN IRELAND) ORDER 1996 MODIFICATIONS PROPOSED TO GAS CONVEYANCE LICENCES

The Northern Ireland Authority for Utility Regulation (the **Authority**) proposes to modify the conditions of certain gas conveyance licences in exercise of its powers under Article 14(1) of the Gas (Northern Ireland) Order 1996 (the **Order**).
