NOTICE UNDER ARTICLE 8(6) OF THE GAS (NORTHERN IRELAND) ORDER 1996

Pursuant to Article 8(6) of The Gas (Northern Ireland) Order 1996 ("the Order") the Northern Ireland Authority for Utility Regulation ("the Authority"), hereby gives notice as follows:

- 1) The Authority, in accordance with Article 8(2)(a) of the Order, has granted an extension to the licence to supply gas (the "licence") held by Flogas Natural Gas Limited (the "Licensee") by increasing the authorised area of the licence.
- 2) The authorised area is set out in Schedule 1 of the licence and this area has been extended to include the West Area. The West Area is the Licensed Area within Schedule 1 of the licence granted to Scotia Gas Networks Northern Ireland Ltd¹.
- 3) The extension will allow the Licensee an opportunity to supply gas to customers within the West Area when the network in the West Area has been developed.
- 4) The Authority considered that granting the extension was an appropriate course of action for it to take as such grant is in keeping with the Authority's principal statutory objective in that it promotes the development and maintenance of an efficient, economic and coordinated gas industry in Northern Ireland.
- 5) On 7 October 2015, the Authority published notice², under Article 8(4) of the Order, of its intention to extend the licence. The Authority asked for any representations or objections with respect to the proposed extension to be made on or before 7 November 2015. We received one response which was supportive of the proposed extension. A copy of this response is available on our website.
- 6) A copy of the extended Schedule 1 of the licence is appended to this notice. The consolidated licence is also available to view on our website.
- 7) The Authority has served a copy of this notice on the licensee and sent a copy to the Department of Enterprise Trade and Investment. The Authority has also sent a copy of this notice to the Consumer Council.

Annex 1 – extract from Flogas Natural Gas Ltd's gas supply licence

SCHEDULE 1

Designated Area and Premises

- 1 The premises designated as a term of the licence in this Schedule 1 are any person or premises:
 - (a) in the Greater Belfast Area;
 - (b) in the Ten Towns Area; and
 - (c) in the West Area.

2 In this Schedule:

means the Licence for the Conveyance of Gas granted to Bord "BGE Conveyance Licence" Gais Eireann by the Authority pursuant to Article 8(1)(a) of the Order: means the Licensed Area within Schedule 1 of the Phoenix "Greater Belfast Area" Conveyance Licence; "Phoenix Conveyance means the Licence for the Conveyance of Gas granted to Licence" Phoenix Natural Gas Limited by the Authority pursuant to Article 8(1)(a) of the Order; "Scotia Gas Networks means the Licence for the Conveyance of Gas granted to Scotia Gas Networks Northern Ireland Ltd by the Authority Conveyance Licence" pursuant to Article 8(1)(a) of the Order; means the Licensed Area within Schedule 1 of the BGE

"Ten Towns Area" means the Licensed Area wi Conveyance Licence.

"West Area" means the Licensed Area within Schedule 1 of the Scotia Gas

Networks Conveyance Licence.
